- Proof of service for Veterans
- One page document containing all necessary details of a Veterans service
- Personal identifying information, Military
 Occupational Specialties (MOS), awards, education,
 overseas service, etc.
- Discharge document DOD began using in 1950 with DoDI 1336.01
- Prior to 1950 there were many versions: WD AGO 53, WD AGO 55, WD AGO 53-55, NAVPERS 553, NAVMC 78PD, and the NAVCG 553.

Bylaws Section 515

- a. Regular Membership. Only the following may be regular members of the MCL:
- (4) Marines who are serving or have served honorably* in the United States Marine Corps "ON ACTIVE DUTY," for not less than ninety (90) days and earned the Eagle, Globe, and Anchor or have served or is currently serving in the United States Marine Corps Reserve and have earned no less than ninety (90) Reserve Retirement Credit Points.(Rev 2022)
- (2) U.S. Navy Personnel
- (i) who are serving or have served honorably* in the United States Navy and who have trained with Marine FMF units in excess of ninety (90) days and earned the Marine Corps device (clasp) worn on the Service Ribbon, (i.e.: Southwest Asia Service Medal, Vietnam Service Medal, Armed Forces Expeditionary Medal, etc.) or;
- (ii) earned the Fleet Marine Force Enlisted Warfare Specialist Device (FMFEWS) (1 Oct 2006 to present) or the Fleet Marine Force Officer (FMFQO) Insignia (1 Jan 2006 to present) which must be noted on the DD214 form. An Award of the Fleet Marine Force Ribbon (FMF Ribbon) (1Sept 1984-30 Sept 2006), the FMFEWS or FMFQO may serve as prima facie evidence of eligibility.

 Note * "Served Honorably" is determined by the last DD Form 214 or certificate of discharge that the applicant received. A General Discharge under Honorable Conditions is acceptable.


